



## Public Consultation on Risk-based Global Insurance Capital Standard – Format of Consultation Tool

Thank you for your interest in the public consultation on the Risk-based Global Insurance Capital Standard (ICS). This document provides an overview of the ICS consultation tool on the IAIS website, in order to facilitate the collation and organisation of responses by respondents to the ICS Consultation Document which was published on 17 December 2014.

Comments are sought in the consultation tool first by questions, then by sections/sub-sections.
